**The Electricity Act 1989 Section 36**

**The Application of Fferm Wynt Llaithddu Cyf ("FWL") dated 9 May 2008 to construct and operate a 66.7 MW wind turbine generating station in Powys, Mid Wales ("LLaithddu")**

1. We act on behalf of FWL in connection with its application for a 66.7 MW wind turbine generating station at Llaithddu. The application is the subject of a conjoined public inquiry with 4 other applications for wind farms in Mid Wales and the application by S P Manweb Plc for consent to install a 132 kV overhead electric line from the Llandinam wind farm to Welshpool Substation.
2. By its application dated 9 May 2008 our client FWL seeks consent to the installation of 29 x 2.3 MW wind turbines at Llaithddu. On 14 June 2013 FWL by its consultants RPS submitted supplemental environmental information to the Secretary of State. This supplemental environmental information ("SEI") considered (inter alia) not just the original proposal for 29 turbines and associated infrastructure but two further options referred to in the SEI as Option 1 and Option 2.
3. Option 2 is an alternative proposal for 27 turbines and associated infrastructure. This proposal is as set out in paragraph 1.6.3 of the Further Environmental Information drafted by FWL's Environmental Consultants, RPS, briefly comprises the same amendments as referred to in paragraph 1.6.2 for Option 1, together with the deletion of turbines 1 and 2 and the relocation of turbines 3 and 4. These changes are intended to mitigate cumulative impacts on the Curlew and follow proposed discussions with Natural Resources Wales. A plan showing the layout of the turbines is attached.
4. Paragraph 1.6.3 of the SEI proposes that Option 2 only be adopted if the adjoining Llandinam wind farm is also consented. FWL instruct us to notify you that they wish their application to proceed on the basis of Option 2 (27 turbines) in any event, this is irrespective of whether or not Llandinam is
