**Mid Wales Public Inquiry
Our Client: Vattenfall - proposed Llanbadarn Fynydd wind farm**

In 2007 Vattenfall submitted an application under section 36 of the Electricity Act 1989 to the Department of Energy and Climate Change together with a request for deemed planning permission under section 90 of the Town and Country Planning Act 1990 (as amended). The application is to construct and operate a 17 turbine wind farm on land north of Llanbadarn Fynydd, Radnorshire ("the Site"). It is currently the subject of a conjoined Inquiry running from June 2013 to May 2014.

The application also seeks permission to undertake improvement works to land which lies along the proposed route to the Site, some of which falls outside the boundaries of the public highway. Following recent consultation with the Welsh Government, amendments to the application to facilitate access to the Site south of Newtown are proposed.

We have therefore enclosed a copy of the revised plans showing the extent of the red line application boundary in relation to the transport works, which have also been deposited at Powys County Council's office at The Gwalia, Ithon Road, Llandrindod Wells, Powys LD1 6AA and can be viewed online at <http://www.vattenfall.co.uk/en/sei-llanbadarn-fynydd-wind-farm.htm>. We confirm that we have also notified the known landowners along the route and will be publishing a notice in the County Times to notify those in the locality during the week commencing 24 February 2014.

We have also copied in the Programme Officer (on behalf of the Inspector) for information.
